



Dog Licensing Information

If your dog's rabies shot expires before November 1, 2012, you must get your dog a new rabies shot before we can release your 2012 dog license to you.

Proof of Rabies Inoculation is required for issuance of a license and registration tag; Rabies Vaccination Requirement: N.J.S.A. 4:19-15-3a requires that the duration of the immunity extends throughout at least the first ten (10) months of the twelve (12) month licensing period.

If your dog has been spayed or neutered, the dog license fee is \$13.00. If your dog has not been spayed or neutered, the dog license fee is \$16.00. A person applying for a dog license and registration tag shall pay a fixed fee which includes the sum of one (\$1.00) dollar for the registration tag; twenty (\$0.20) cents for the Department of Health of the State of New Jersey Pilot Client Fund and three (\$3.00) dollars additional surcharge on all licenses issued for non-spayed and non-neutered dogs for the State Treasurer for the Animal Population Control Fund. Owners presenting a certificate signed by a licensed veterinarian certifying that their dog has been sterilized are exempt from the three (\$3.00) dollar surcharge.

Registration tags and renewals thereof shall expire on January 1st of each year. A late fee of five (\$5.00) dollars shall be assessed if a renewal fee is paid after January 31st.

You may obtain your dog license either by mail or in person at the Neptune City Borough Hall, 106 W. Sylvania Avenue, Neptune City, NJ. Please make checks payable to the Borough of Neptune City and include a self address envelope. You must include Proof of Rabies Vaccination, and if your dog has been spayed or neutered, you must also include this proof with your application.
