The Neptune City Board of Recreation will once again offer their Summer Recreation Program from June 29th through August 21st from 9:00am to 3:00pm. The program will utilize Adam's Field, Memorial Park and the Community Center. It is open to Neptune City and Avon children between 5 and 12 years of age. Activities will include games, arts and crafts, sports and field trips. A snack will be provided each day in the am session.

The fees are as follows:

Full Day Program

\$675.00 per child for the eight week program
\$650.00 for each additional child in the same family

OR

\$100.00 per week per child
\$95.00 for each additional child in the same family

OR

\$75.00 per child for a (3 day only) partial week
\$70.00 for each additional child in same family

AM or PM session only (9-12 or 12-3)

\$385.00 per child for the eight week program
\$365.00 for each additional child in the same family

OR

\$65.00 per week per child
\$60.00 for each additional child in the same family

No partials on AM or PM only

The attached application should be returned to the Neptune City Community Center on or before Friday May 1st. A non-refundable \$25.00 deposit per child is required with the application. The balance is due by June 5th. Please make checks payable to: Neptune City Board of Recreation. Enrollment in the program will be limited. Applications received after May 1st will be accepted contingent upon availability.
