AUDIT REPORT YEAR: DECEMBER 31, 2020

Department of Finance, William E. Antonides, Jr., CFO

Finding 2020-01

Finding: The analysis of the various accounts in the Other Trust Fund revealed that there are considerable amounts unidentified in the fund.

Effect: There is uncertainty of related to the nature of the various trust reserve balances.

Recommendation: Internal controls over the preparation and fair presentation of financial statements in accordance with the accounting principles promulgated by the Division of Local Government Services should be reviewed and revised as needed to reasonably ensure the accounting policies of the governing body and those of Division of Local Government Services are being carried out as intended, and also to ensure the safe keeping of assets of the tax payers. Also, a detailed analysis of all the trust reserves should be prepared and if this is not possible, then action should be taken to cancel any unidentified balances. That a detail of all the trust reserves be proven on a monthly basis.

Management's Response to Finding: The Other Trust Fund was not accurately maintained by the Borough of Neptune City from at least 2007–2015. The current Chief Financial Officer and Tax Collector attempted to analyze the aforementioned years in an attempt to reconcile the account however, numerous records that would be needed to substantiate the balance are not available. The unidentified balances cannot reasonably be identified.

Corrective Action: The Borough will cancel the unidentified balances in the Oher Trust Fund by resolution.

Finding 2020-02: During our testing it was noted that 75 of 100 samples tested did not have proper approval by the Chief Financial Officer or Business Administrator on the purchase orders.

Effect: There is a possibility that a purchase order was created or completed with a proper approval.

Recommendation: That all purchase orders or requisitions be approved with a signature before the purchase of goods or services.

Management's Response to Finding: The Coronavirus Disease of 2019 impacted the daily operation of Borough of Neptune City as well as the Nation as a whole. During certain periods there was limited staff in the municipal building. This resulted in the manual signatures which were needed for the approval of purchase orders being done verbally.

Corrective Action: The Borough realized that this was not ideal situation and has since migrated its finance software to the cloud. This has permitted the electronic approval of purchase orders and eliminated the need for manual signatures on purchase orders.

RESOLUTION 2021-142 GOVERNING BODY CERTIFICATION OF THE ANNUAL AUDIT

WHEREAS, the Local Finance Board of the State of New Jersey is authorized to prescribe reports pertaining to the local fiscal affairs, as per R.S. 52:27BB-34, and,

WHEREAS, the Local Finance Board has promulgated a regulation requiring that the governing body of each municipality shall by resolution certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled:

WHEREAS, the members of the governing body have personally reviewed as a minimum the Annual Report of Audit, and specifically the sections of the Annual Audit entitled:

as evidenced by the group affidavit form of the governing body, and,

WHEREAS, such resolution of certification shall be adopted by the Governing Body no later than forty-five days after the receipt of the annual audit as per the regulations of the Local Finance Board, and,

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board, and

WHEREAS, failure to comply with the regulations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52:27BB-52, to wit:

R.S. 52:27BB-52: A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office.

RESOLUTION TO APPROVE THE BOROUGH OF NEPTUNE CITY TO ENTER INTO A SHARED SERVICES AGREEMENT WITH THE COUNTY OF MONMOUTH TO PROVIDE THE ITAX MAP/COLLABORATION CENTER SYSTEM

(tax map conversion and maintenance services)

WHEREAS, the Uniform Shared Services and Consolidation Act (C.40A:565-1, et seq.) authorizes local units of this State to enter into a contract with any other local unit(s)n for the join provision within their several jurisdictions of any service, which any party to the agreement is empowered to render within its own jurisdiction, and

WHEREAS, each municipality is to provide for the preparation of yearly revisions to the tax map under New Jersey State law N.J.A.C. 18:23A-1.1, and this legal requirement is not followed by all municipalities based on limited financial, technical and professional resources, and

WHEREAS, each physical description of a parcel of land drives the mass-appraisal calculation of the land portion of its property tax assessment, and land data inaccuracies and errors lead to poor distribution of the annual tax levy, potentially resulting in years of tax bill overpayments and underpayments, and

WHEREAS, a County-to-Municipality shared services program would provide map conversion and maintenance services, ushering in the transition from analog to a Countywide standard of state-certified digital tax maps for all 53 municipalities, and

WHEREAS, the intent of the digital tax map shared services program is to reduce municipal costs in complying with the law and provide for the most up-to-date GIS parcel layer and tax map data for public and government stakeholders, and

WHEREAS, this service provides participating municipalities with numerous benefits, including: anticipated cost-savings through economies-of-scale; reduce cost to comply with state regulations and standards; transition from analog to state-certified digital maps; streamlined editing and ongoing maintenance procedures; more consistent and accurate municipal and County-wide information; unprecedented assemblage of data made available to taxpayers, municipalities and the County; and seamless flow of tax information into GIS and additional information systems.

WHEREAS it is in the best interest of the Borough of Neptune City to enter into such an agreement, and

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Neptune City hereby approves entry in the Agreement with the County of Monmouth consistent with the foregoing.

BE IT FURTHER RESOLVED, that the Mayor, Borough Administrator and Municipal Clerk are each hereby authorized and directed to execute the attached Shared Services Agreement, for the provision of the iTax Map/Collaboration Center System on behalf of the Borough.
