MAYORS REPORT: Mayor Andrew Wardell Mayor Wardell reported on the following:

#### I.Covid-19:

- A. Today there are 160 new cases being reported.
  - 1. County 63,991 since March 2020
  - 2. Neptune City 488 since March 2020
- B. Hospitalizations

1. As of April 12, there are 298 hospitalized, 51 in intensive care (ICU) and 31 on ventilators in Monmouth County due to COVID-19.

# C. Testing

1. Monmouth County will offer free COVID-19 testing for County residents on Tuesday, April 13 in Long Branch from 4 p.m. to 7 p.m. at the Bucky James Community Center located at 231 Wilbur Ray Ave. Residents should note the clinic has 200 tests and once those are administered, the clinic will close for the day.

#### D. Vaccinations

- 1. County is offering 500 vaccines a day. People can sign up at <a href="https://www.visitmonmouth.com/health">www.visitmonmouth.com/health</a>. No one will be vaccinated without an appointment.
- 2. We are approaching 50% of all NJ adults being fully vaccinated.
- II. Memorial Park/Summer events
- A. Gazebo foundation has been poured
- B. Movie in the park dates have been set and will be made available soon.
- C. The Board of Rec has also planned family friendly events for the summer as well.
- D. I would like to explore the possibility of creating a position to plan and coordinate events here in town.
- E. I have a meeting planned for next week to see if we can schedule the Neptune City Fall Festival. This was something we had planned in early 2020 for the fall of 2020 until Covid-19 hit. We have been reluctant to set a date, but as more and more people are being vaccinated I am more optimistic.

### III. Mayor's Council

- A. I recently had a meeting with Mayor Fox of Bradley Beach to discuss the upcoming plans to renovate Memorial Ave.
- B. I have been floating an idea to create a local Mayor's Conference for our local Mayors to discuss more local issues.
- IV. Land Use Board
- A. Tomorrow night's LUB meeting will be held in person at the Community Center.
- B. Land Use Board will vote to approve the findings of our planner that Blocks 18 and 13 Lot 1 is in need of non-condemnation redevelopment.
  - 1. Block 13 is the old East Coast Ice property. The area is in need a remediation and under this redevelopment this undertaking will not be done with public monies.

- 1. 2021 Municipal Budget
  - > We just completed a council workshop meeting to discuss this year's municipal budget. Thank you to our CFO, Bill Antonides, for preparing the budget.
  - > The presentation dates are as follows:

    - Public Hearing on May 24, 2021
    - · Adoption upon receiving final numbers from the State.
- 2. Road Improvements to Steiner Avenue
  - > Ben Matlack (CME Engineering) and I met with representatives from Monmouth County Engineering Department on Friday to discuss coordinating our efforts for the road improvement projects on Steiner Ave. We have a grant through the County CDBG Program for curb, sidewalk and ADA ramp improvements and the county will be implementing a traffic calming initiative. We were notified the County Commissioners adopted a resolution at their April 8th meeting to reduce the speed limit from 35 to 30 mph on Steiner Ave. as part of their traffic calming plan. New speed limit signs should be going up this week.
- 3. Grant Opportunities
  - We have received information regarding potential grant opportunities.
    - New Grant NJ Local Recreation Improvement Grant (LRIG) through DCA (due 5/24/21)
