Mayor's Report – Mayor Wardell

Mayor Wardell offered condolences to Sgt. Nick Morgan whose mother passed away. Mayor Wardell reported on the Fall Food Truck Festival, noting all events set. There will be 5 Food trucks, 1 Beer truck, Musical Acts a Petting Zoo, Touch a Truck and possible Pet Adoption. The 9/11 Ceremony has tentatively been rescheduled for Saturday, September 10 to allow for our Honor Guard to be able to attend. Mayor Wardell shared he held a meeting with the Monmouth County SPCA, the Monmouth County Board of Health, the Neptune City Police Department and Neptune City Code Enforcement about the issue of feral cats in Neptune City last Thursday here at Borough Hall. There is a plan to expedite the health issue that cat urine can cause and the plight of some of resident's health. The Borough also continues our partnership with the MCSPCA for the TNR program to help mitigate the feral population, but some of the areas are beyond that now and are going to be addressed more stringently. Board of Recreation member John O'Heney has informed me that he will be resigning from the BOR. I want to publicly thank John for all of his service to Neptune City and the Board of Recreation. I received the following message from a resident who asked to remain anonymous about our library and Librarian. "One of the best things about Neptune City is the treasure right in the library. Our library offers more than books and DVDs. Our library also has a librarian staff who cares about the general well-being of others. While interacting with and listening to the library patrons, they often become therapists, guidance counselors, teachers, computer experts and friends in addition to librarians. They all have a distinct, upbeat personality, and I can visit the library on any given day and enjoy a shared moment in time with them that automatically brightens my day. Having librarians who are knowledgeable and informative is only a part of the job that they do so well; but the other, maybe more valued, part is the connection that they form with others and taking an interest in their

daily lives while still remaining professionals. They just do this so naturally that they probably don't realize how many people they touch every day in a positive way. If you should share this note with others, I would prefer staying as an anonymous grateful Neptune City resident". The Mayor offered thanks to Theresa Riccardello and our staff for the wonderful work they do. Mayor Wardell thanked the Somerset County Library for the donation to WWES of virtually brand-new shelving for the school's new media center/library. Mayor Wardell also shared to the DPW for their helpfulness in transporting the material to the school from Somerset County. Also thank you to SRO Andy Hansen and recently retired NCEA president Cathleen Williams for finding this great deal. Mayor Wardell noted he looks forward to being at the dedication. Mayor Wardell noted he often will praise our first responders in my report. I have the utmost respect for what they do. Mayor Wardell shared the details of a recent accident that occurred near his home and the response of the First Responders, expressing his deep appreciation for their professionalism and service. Mayor Wardell then shared a letter from a resident: "I hope this letter finds you well. I am writing to you today to give you and the NCPD, NCFD, and most importantly your NCFA organizations a big thank you from our family. They were involved in the 911 call yesterday for my mother. I absolutely must commend the first responder on scene EMT Sestito. The respect that he and the rest of the crews showed my mother was outstanding. To deal with a homebound resident and her comorbidities is an extreme feat, and the poise with which they did it was no short of exemplary. Our family absolutely commends all of your departments. This letter is simply to let you know the quality of people that you have working in Neptune City. If there is any type of recognition that is beyond well deserved, it should be given to all three of your organizations in totality, under the direction of EMT Sestito. They all equally displayed unbiased teamwork and respect to her in her time of need. She has a long road ahead of her, but we wanted to give respect and credit where it is undoubtedly due. Please express our extreme gratitude that our family has for your crews and volunteers. We hope that no one has to be in the predicament that she was in; but when your residents need your services, they will be in good hands...and muscles!".

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF NEPTUNE CITY, IN THE COUNTY OF MONMOUTH, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring), AS FOLLOWS:

Section 1. Bond Ordinance 2021-02 of the Borough finally adopted May 10, 2021 and entitled an Ordinance of the Borough of Neptune City, County of Monmouth, providing for the Steiner Avenue Pedestrian and ADA Improvement Phase 3 in and for the Borough of Neptune City and appropriating \$425,000 therefor and providing for the issuance of \$245,935 in bonds and notes of the Borough of Neptune City to finance the same.

Section 2. Sections 2 and 3 are hereby amended to read as follows: Steiner Avenue Pedestrian & ADA Improvement Phase 3 and Various Road Improvements.

Section 3. This bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.

ORDINANCE 2022-13

AN ORDINANCE APPROPRIATING \$20,000 FROM CAPITAL IMPROVEMENT FUND FOR POLICE STORAGE TRAILER

BE IT ORDAINED by the Borough Council of the Borough of Neptune City, in the County of Monmouth, New Jersey (not less than two-thirds of all members thereof affirmatively concurring) as follows:

Section 1. The capital improvements described in Section 2 of this Bond Ordinance are hereby authorized by the Borough of Neptune City, New Jersey. For the capital improvements described in Section 2, an amount of \$20,000 is appropriated from the Capital Improvement Fund to finance the total cost.

Section 2. The following purchases are hereby authorized:

Police Storage Trailer \$20,000

The minimum period of usefulness is five years.

Section 3. The capital budget of the Borough of Neptune City is in agreement with the provisions of this Ordinance.

Section 4. The following additional matters are hereby determined, declared, recited and stated:

The purchases described in Section 2 of this bond ordinance are not a current expense. It is an improvement that the Borough may lawfully undertake as a general improvement, and no part of the cost thereof has been or shall be specially assessed on property specially benefitted thereby.

Section 5. This bond ordinance shall take effect twenty (20) days after the first publication thereof after final adoption, as provided by the Local Bond Law.
