BOROUGH ADMINISTRATORS REPORT: Christopher Cherbini

MAYORS REPORT: Mayor Andrew Wardell Mayor Wardell reported on the following:

I. Covid-19:

- A. As of today, we have 284 new cases as of today in Monmouth County bringing our total to 25, 775
- B. Neptune City has 187 confirmed cases
- C. Testing has become more scarce as many people have required multiple tests to return to work. County is still providing free testing to residents.
 - 1. We will continue to post testing sites on our website

II. WWES:

III. JCP&L:

- 1. Has donated \$1,000 to the Neptune City Christmas party. Since we will not be able to have the party this year we have decided to use a portion of that money to buy gift cards from the restaurants who donated to our Halloween decorations contest and use them as prizes for the Christmas decorations contest. I thank Frank Luna and JCP&L for the donation.
- IV. The Decorations contest will be held through Christmas but submissions must be received by 12/20. Top prizes are gift cards from Kelly's, Pete N Eldas, and Molinaris.

V. Tree Lighting:

VI. BOH:

- 1. I will be attending the BOH meeting on Tuesday to discuss vaccine distribution here in Monmouth County
- VII. Police Letter: Mayor Wardell read a letter received from Neptune Township EMS for a call that was received for an autistic child having a difficult time. The letter commended Sergeant Pyzik and Officer Edwards. Mayor Wardell spoke about how proud he is of our NCPD.

ADMINISTRATION & FINANCE- Brian Thomas

C/Thomas reported the operating budget meeting took place. He mentioned we started early because we are entering an unsure fiscal climate for 2021. The meeting took place with Administrator Cherbini, CFO Antonides and all the department heads. The borough currently is in good shape fiscally. He also thanked the CFO Antonides and Administrator Cherbini for a great job.

C/Pietrunti reported that brush pick up ended on December 1. He commended the DPW on a job well done. He also mentioned that leaf pick up ends on December 15. The DPW has installed the new borough sign and it should be activated within the next few days.

C/Pappas stated that this pandemic has affected everyone but especially the first responders. She wanted everyone to know that a little prayer will go a long way, and if you see a first responder to say thank you because that also goes a long way. AN ORDINANCE TO AMEND AN ENTITLED "AN ORDIANCE OF THE BOROUGH OF NEPTUNE CITY IN THE COUNTY OF MONMOUTH AND STATE OF NJ FIXING THE SALARIES OF CERTAIN OFFICES AND EMPLOYEES" ADOPTED MARCH 4, 1965

BE IT FURTHER ORDAINED by the Governing Body of the Borough of Neptune City, County of Monmouth in the State of New Jersey that the following minimum and maximum salaries and other remuneration shall be paid to the officials and employees of the Borough of in accordance with the provisions of this Ordinance, as set forth below during the calendar year 2021 with said rates being effective January 1, 2021.
