Mayor's Report - Mayor Wardell

Mayor Wardell wished all a Merry Christmas and Happy New Year. Mayor Wardell thanked the school for the use of the facilities. He thanked the Neptune City Fire Department for hosting Santa on the Firetruck on Christmas Eve, sending special thanks to Santa for braving the cold. Mayor Wardell congratulated Captain Hoover, Lieutenant Volbrecht and Sergeant Halgring and welcomed Patrolman Emmons and Sceppeguercio. Mayor Wardell reported on the very large, destructive fire at Brighton Arms; commending the bravery of the Neptune City Police Department and Fire Department. Mayor Wardell provided more detail on the heroism and bravery of the Fire Department and the destruction to several units. Mayor Wardell spoke of the generosity of businesses, private citizens, social organizations, churches and more who provided beyond measure. Mayor Wardell thanked the Police Department who remained in contact with the residents even after the fire; the Fire Department; Administrator Al Jardine; all Councilmembers and their spouses; the Neptune City and Neptune Township CERT teams, especially Sharon Dellett; Tom Arnone and PRC for finding housing for all displaced residents; and Recreation Director Tom Adcock who took the time to build a relationship with all those affected. He noted overwhelming amount of gift cards were donated to those affected. Mayor Wardell thanked the good people of Neptune City for their generosity and good will. Mayor Wardell invited all to the reorganization meeting on January 1, 2023 at Borough Hall in Council Chambers at noon. Mayor Wardell suggested changing the reorganization meeting to the first Monday after the first, asking Council to give it some thought.

ORDINANCE NO. 2022-14

BOROUGH OF NEPTUNE CITY, COUNTY OF MONMOUTH

ORDINANCE AUTHORIZING THE VACATION OF THE UNIMPROVED PAPER STREET DESIGNATED AS "FIELD STREET" ON THE OFFICIAL TAX MAP OF THE BOROUGH OF NEPTUNE CITY

WHEREAS, the Borough of Neptune City (the "Borough") has determined that the unimproved paper street designated as "Field Street", as shown on the official tax map of the Borough, is not needed for any public purpose, and that the public interest would be best served by vacating and extinguishing all public right, title and interest in and to that portion of Field Street, so that the underlying lands may be combined with, and become and form part of, adjacent properties; and

WHEREAS, the area of Field Street to be vacated (the "<u>Subject Area</u>") measures approximately 2,939 square feet, and is located adjacent to Block 18, Lot 1, which is a privately-owned lot commonly known as 96 Laird Avenue ("<u>96 Laird Avenue</u>"), and Block 8, Lot 6, which is public park owned by the Borough (the "<u>Laird Avenue Park</u>"); and

WHEREAS, the Subject Area, 96 Laird Avenue and the Laird Avenue Park are all located within a Non-Condemnation Area in Need of Redevelopment, as determined by the Borough Council of the Borough of Neptune City through Resolution No. 21-81 dated April 26, 2021 (the <u>"Redevelopment Area"</u>); and

WHEREAS, the Borough and Genesis Redevelopment, LLC (the "Redeveloper") are party to a Redevelopment Agreement approved via Resolution 22-95 dated July 25, 2022 intended to facilitate the redevelopment of 96 Laird Avenue and another lot within the Redevelopment Area, and the rehabilitation of the Laird Avenue Park (the "Redevelopment Agreement"); and

WHEREAS, the Redevelopment Agreement provides that vacation of the Subject Area is conditioned upon the Redeveloper's acquisition of title to 96 Laird Avenue and shall serve as consideration for the rehabilitation of Laird Avenue Park by the Redeveloper; and

WHEREAS, the Subject Area is shown on a survey prepared by Kevin E. Shelley, P.E. of Shore Pointe Engineering, dated October 10, 2022, a copy of which is attached hereto as **Exhibit A** and made a part hereof, and is more particularly described in a legal description prepared by John W. Lord, P.L.S., a copy of which is attached hereto as **Exhibit B** and made a part hereof; and

WHEREAS, it is the intention of the Borough that once the Redeveloper acquires title to 96 Laird Avenue, the Borough's interest in the Subject Area will be vacated and the ownership of the underlying lands shall revert to the Redeveloper as the owner of 96 Laird Avenue by operation of law; and

WHEREAS, when not necessary for any public use, a public street, or part thereof, which has not been opened by the municipality, may be vacated by the governing body by Ordinance pursuant to N.J.S.A. 40:67-19, et seq.; and

WHEREAS, the Borough believes that the vacation of all public right, title and interest in and to in the Subject Area is in the best interests of the Borough as well as the adjacent property owners and is consistent with the policy underling the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1, et seg.

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Neptune City in the County of Monmouth, State of New Jersey, that:

- 1. Pursuant to N.J.S.A. 40:67-19, et seq., and contingent upon the Borough acquiring title to 96 Laird Avenue, the Borough hereby vacates, extinguishes, releases and abandons all public right, title and interest in and to that unimproved paper street known as Field Street which is located immediately adjacent to Block 18, Lot 1 and Block 8, Lot 6, and is an area that measures approximately 2,939 square feet, as more particularly shown on **Exhibit A** attached hereto, and as more particularly described in **Exhibit B** attached hereto.
- 2. It is the intention of the Borough that once the Subject Area has been vacated, then ownership of the underlying lands shall revert to the Redeveloper by operation of law conditioned upon its prior acquisition of title to 96 Laird Avenue.
- 3. The provisions of this Ordinance shall not be deemed to vacate any rights and privileges which may be possessed by any public utility company (as defined in N.J.S.A. 48:2-13), or by any cable television company (as defined in N.J.S.A. 48:5A-1, et seq.), to maintain, repair, and replace any existing facilities in, adjacent to, over or under the said vacated area.
- 4. Following the introduction of this Ordinance, the Borough Clerk shall provide notice of its pending status as mandated by N.J.S.A. 40:49-6, and at least one week prior to the time fixed for further consideration and final passage of the Ordinance, the Borough Clerk shall mail a copy of the Ordinance, together with a notice of the introduction thereof, and information as to the time and place of when and where the Ordinance will be further considered for final passage, to every person whose lands may be affected by the Ordinance, by certified mail return receipt requested and regular mail, to their last known post office address(es).
- 5. Following the adoption of this Ordinance, the Borough Clerk shall within sixty (60) days of the effective date thereof, file a copy of this Ordinance along with the attached exhibits, certified by the Clerk, under the Seal of the Borough, to be a true and exact copy of the Ordinance, together with a copy of the proof of publication thereof, in the Office of the Monmouth County Clerk for recordation in the County's Book of Vacations, pursuant to N.J.S.A. 40:67-21.
- 6. Once the Subject Area has been vacated following the Redeveloper's acquisition of title to 96 Laird Avenue, then the Borough's interests in and to the said area shall be extinguished.
- 7. The Borough Attorney and Borough Engineer are hereby authorized and directed to undertake all actions and to prepare all documents that are necessary in order to effectuate the intentions of this Ordinance.
- 8. The Mayor and/or the Borough Administrator are hereby authorized and directed to execute any documents necessary to effectuate this Ordinance.
- 9. All costs and expenses associated with this Ordinance shall be the responsibility of the current contract purchaser of Block 8, Lot 6, and sufficient funding shall be posted by said property owner prior to the adoption of this Ordinance to cover all Borough's expenses associated with this Ordinance.
- 10. This Ordinance shall take effect immediately upon final passage and publication in accordance with the law.
- 11. The provisions of this Ordinance shall be severable. In the event that any portion of this Ordinance is found to be invalid for any reason by any Court of competent jurisdiction, such judgement shall be limited in its effect only to the portion of the Ordinance actually adjudged invalid and shall not be deemed to affect the operation of any other portion thereof, which shall remain in full force and effect.
- 12. That all other Ordinances or parts of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistencies.

Mr. Eugene O'Connell, Steiner Avenue, shared his appreciation for the Police Department. He further stated he did not think enough research had been done on 2021-04 or regarding reviewing and picking the applicants for the cannabis facilities. Mr. O'Connell further commented on concerns regarding traffic issues and raised questions regarding the qualifications of candidates. Mr. O'Connell shared he feels the whole matter needs to be reconsidered.

Mr. Joe Callahan, Greene Avenue, noted he loves the quietness of the neighborhood and shared experiences from Maplewood regarding nuisance crimes and traffic.

Mr. Christopher Defoe, Riverview Avenue, requested Ordinance 2021-04 be reconsidered or removed.

Mr. Jim McGreevy, Steiner Avenue, requested Council reconsider, amended or repeal Ordinance 2021-04. He noted concerns with traffic studies and proximity to homes. Mr. McGreevy shared the opinion that the matter should be considered with the public input.

Mr. Dave Winberry, Steiner Avenue, requested Council strongly think of repealing or removing Ordinance 2021-04.

Mr. Pat Gallgher, Steiner Avenue, asked Council to repeal 2021-04.

Mr. Kenneth Zilinszky, Belle Place, noted he sent a letter via the CAC Committee. He then expressed his opposition to Ordinance 2021-04 and the resolutions of support for the Cannabis facilities. Mr. Ziliniszky spoke about the need for a distance buffer, traffic concerns, and questions over the procedure for land use board review of Ordinance 2021-04.

Ms. Molitia Rosas, Steiner Avenue pleaded with the Governing Body to repeal and revoke Ordinance 2021-04. Ms. Rosas expressed concerns regarding lot size, parking spots needed, hours of operation which would have to be permitted by the Land Use Board due to the language of the ordinance.

Mr. Jay O'Connell, Belle Place, questioned how much money the Borough would receive from the cannabis facilities. Mr. O'Connell expressed concerns over the destruction of the neighborhood. Mr. O'Connell expressed dismay over what the town will receive vs what will be destroyed.

Ms. Tina Roberts, Oak Terrace, expressed disappointment that the Council did not ask the residents in the area before moving forward. Ms. Roberts further spoke of concerns over increased accidents and lack of volunteers for the First Aid. Ms. Roberts further spoke of traffic concerns and reiterated her disappointment.

Ms. Rose, Oak Terrace, requested Council review the Ordinance noting it will not impact the Council, but will the residents.

Ms. Marylou Collins, Boston Road, shared she is distraught over the decision due to the increase in traffic and decrease in property values.

Mr. Gary Conlin, Steiner Avenue, requested Council reconsidered the ordinance.

Ms. Arlene Scriappa, Tucker Drive, shared her love of the town, noting that whatever benefits Council thought they would receive would not be the right fit for the community of Neptune City. Ms. Scriappa requested Council amend or replace Ordinance 2021-04.

Mayor Wardell thanked residents for coming forward to bring their concerns to the attention of the Governing Body. He further noted there are legal reasons the Council cannot respond, but that all members are also residents and will work in the new year to come up with a solution palatable to everyone. He wished all a Happy New Year.
