BOROUGH ADMINISTRATORS REPORT: Christopher Cherbini

A/Cherbini reported that the Cares Act funding is coming to a close. We submitted for reimbursement of \$170,000 and we should receive it back. Thank you to CFO for his work.

MAYORS REPORT: Mayor Andrew Wardell Mayor Wardell reported on the following:

I.2020 in Review

A. Park improvements

- 1. First Responder's Park was started and completed in 2020.
- 2. Memorial Park
 - 1. New Playground equipment
 - 2. New 40x40ft. Gazebo
 - 3. New handicap accessible beach mats
 - 4. Kayak racks which were budgeted for in 2019 were constructed this year.
- 3. Joe Freda Park had its playground surface redone and new fencing
- 4. Adams Field is in the beginning stages of revitalization

B. Budget/Borough Business

- 1. We were able to create a budget with a reduction in taxes for the Borough despite the pandemic
- 1. Thank you to Chris Cherbini
- 2. Bill Antonides
- 3. Brian Thomas
- 4. Department Heads
- 2. This year we negotiated new contracts with DPW and PD.
 - a) DPW was working without a contract throughout all of 2019, but continued to do a tremendous job.
 - b) NCPD has finalized negotiations and are ready to have their new 4 year contract approved tonight.
- 3. Because of smart fiscal planning we were able to offer to our residents a suspension of property taxes of the third quarter.
- 4. We have restructured our budget process to plan out 5 years in advance. This advanced planning was put into place to protect our residents in the future. This will help protect against the state government's lack of aid in the future.
- 5. We began our Neptune City Business Connection to make our business owners part of our community and help grow the business community.
 - a) Thank you to Danielle Pappas for spearheading this.
- 6. Neptune City was able to grow business despite the pandemic. We had more business in NC in 2020 than in 2019.
- 7. We also instituted new savings programs such as Centralized Purchasing.
 - a) This cut down on operational cost in the Borough
 - b) New agreement with Nixel saved us thousands.

C. Borough improvements

1. We updated our website this year to create a much more user friendly website that is full of information for residents about borough business as well as County and State programs.

- 2. We purchased a new digital signage system for the Borough that will allow us to update information in real time giving yet another avenue to notify residents of borough business.
- 3. We hired a new police officer this year to be sure our PD has everything they need to be successful
- 4. The borough was able to upgrade curbs and sidewalks to multiple streets in Neptune City protecting our infrastructure.
- 5. The Flooding at 35&3rd has been improved after continuous contact from us.
- 1. I have to thank Mr. Thomas for his persistence as well and for helping us find the appropriate channels at the State level.
- 2. This has been a problem here in Neptune City for decades. This solution was at no cost to the borough despite the ideas of permeable road surfaces or pumping stations that cost millions of dollars.

D. Borough Programs

- 1. During the height of the pandemic I instituted a Shop for Seniors program to help those who are unable or feel unsafe shopping for their necessities.
- 2. The Movie in Park series began this year. We purchased the equipment to screen movies all summer as a way of offering a safe outdoor experience for our residents.
- 3. With the BOR we offered many safe and family friendly activities over the summer
- 4. Recently I began our Stigma Free Community initiative here in Neptune City and we have been working with the School and Dr. Boccuti to help those with the stigma of mental health.
- 5. This year I also instituted our first annual contest for Holiday decorations.

II. Covid-19

- 1. Since February we began to hold regular meetings of emergency services.
 - 1. We ensured they had all the PPE they needed
 - 2. Hired a company to sanitize the PD
 - 3. We had testing available for our employees early in the pandemic
 - 4. We only had 1, part-time employee contract Covid-19 and this happened away from the borough.

- 5. I thank Mr. Cherbini, who for several months was the only employee in the borough keeping the continuity of Borough business and allowing the other employees to work from the safety of their homes.
- 6. Neptune City was one of the first Municipalities to reopen to the public in June.
- 7. I will be meeting with Freehold Director Arnone on Wednesday to discuss vaccination distribution here in Monmouth county.

ADMINISTRATION & FINANCE- Brian Thomas

C/Thomas reported had no report but wanted to recognize Rock Solid Gym, he has been collecting food and gifts to give to families in need. He wanted to highlight a great business that comes together as community.

PUBLIC WORKS- John Pietrunti

C/Pietrunti reported that brush pick up ended on December 1. He commended the DPW on a job well done. He also mentioned that leaf pick up ends on December 15. The DPW has installed the new borough sign and it should be activated within the next few days.

ORDINANCE 2020-12

AN ORDINANCE TO AMEND AN ENTITLED "AN ORDIANCE OF THE BOROUGH OF NEPTUNE CITY IN THE COUNTY OF MONMOUTH AND STATE OF NJ FIXING THE SALARIES OF CERTAIN OFFICES AND EMPLOYEES" ADOPTED MARCH 4, 1965

WHEREAS, the Mayor and Council of the Borough of Neptune City seek to introduce an amended salary ordinance to provide for payment of Borough employees, which shall be funded through the necessary budget appropriations; and

NOW THEREFORE, BE IT ORDAINED by the Governing Body of the Borough of Neptune City in the County of Monmouth, State of New Jersey that the following positions are hereby created; and,

BE IT FURTHER ORDAINED by the Governing Body of the Borough of Neptune City, County of Monmouth in the State of New Jersey that the following minimum and maximum salaries and other remuneration shall be paid to the officials and employees of the Borough of in accordance with the provisions of this Ordinance, as set forth below during the calendar year 2021 with said rates being effective January 1, 2021.
