#### **Presentations**

2023 CDBG Application – Riverdale, Locust, Oxford Way and Ridge Avenue

Engineer Shafai gave an overview of prior phases of the project; then provided details of the proposed project for 2023 whereby the Borough will make updates to Riverdale, Locust, Oxford Way, Ridge Avenue and parts of West Sylvania. ADA improvements will be made to the sidewalks, curbs, and driveways. Engineer Shafai provided information on the cost. He also provided detail regarding the CDBG process. Mayor Wardell asked about the probability of receiving funding. Further discussion continued on prior phases of the project.

# Mayor's Report – Mayor Wardell

Mayor Wardell welcomed Corinne to the Borough Clerk's Office. He offered congratulations to Bill Doolittle on his retirement from the Borough after 29.5 years of service. He shared Bill was hired in 1989 by Mayor Wardell and ended his employment under Mayor Wardell, noting Bill wore many hats at the Borough including Construction Official, Zoning Officer, Building Subcode Official and Fire Subcode Official.

#### **Mayors Report Continued**

Mayor Wardell reported George Selah, who has been our Electrical Inspector for 15 years, will take over as Construction Official. Congratulations to George. Stephen LoSacco will be our new Building Sub Code Official. Welcome Stephen. Mayor Wardell referenced A-1294/S-2103 opposition: Neptune City Resolution 22-84. He shared the NJ Senate Bill 2103 would allow a preemption of local and zoning regulations and provide that mixed-use development is permitted use which does not require a use variance. This will essentially take the rights away from any municipalities zoning or planning board to have a say in what can or cannot go into certain properties. It is essentially a state approved eminent domain bill. Mayor Wardell also referenced Borough Resolution 22-30 Restoration of Energy Tax Payments, explaining for many years the Borough had the responsibility to collect the energy taxes from gas and electric for the purposes of compensating the Borough for the use of their rights of way. The state took it upon themselves to become the collection agency for these taxes and to be dispersed to the municipalities, but they have stopped doing that and been using these funds as the State sees fit. We are asking the state to return the funds to the rightful place with the municipalities and help us alleviate the burden on our taxpayers. Mayor Wardell referenced Borough Resolution 22-85 Supporting Assembly Resolution to increase the Property Tax Deduction for Veterans to \$1,000 and base future deductions on Annual consumer price index increases. Mayor Wardell shared he recently sent a letter to the DEP, along with the letter sent by our Senator, urging them to conduct a test of the air quality surrounding the Nylabone factory. I have received the certification that it was received and wait for a response. Mayor Wardell offered Congratulations to the 2022 Graduates, specifically recognizing the Graduates in Neptune City and even more especially the Woodrow Wilson Elementary School graduates. Mayor Wardell shared it was his privilege to attend the WWES graduation ceremony and present the Borough Leadership Award to the Class President Angely Salomon-Jose. He concluded by saying as a WWES graduate and former Class President of the class of 92, he really enjoyed being part of the ceremony.

# **Council Reports**

# Administration & Finance – Council President Brian Thomas

Council President Thomas reported on the Neptune City library schedule of events for July. He also shared information about the book drive event at Woodrow Wilson school. He reported on the 2nd Annual Blood Drive, and noted the Red Cross has requested Neptune City consider hosting a drive near the holidays. C/Thomas shared information on the first movie in the park and candy bingo.

#### Human Services - Councilmember Scott Dellett

C/Dellett shared information from the Fire Department regarding summer safety tips for grills and fire pits.

#### Administration & Justice - Councilmember Dana Farley

C/Farley thanked the PBA for a great steak bake. C/Farley also shared a reminder from the police department that there is no smoking of drinking in the parks.

#### Law & Ordinance – Councilmember Glen Kocsis

C/Kocsis noted he would be calling a meeting soon to discuss permits for gatherings at Memorial Park and to review the Cannabis Ordinance amendments.

#### Public Works – Councilmember Danielle Pappas

C/Pappas shared that public works will be receiving their loader soon, as well as will be getting their new mower.

#### Special Services – Councilmember Pamela Renee

C/Renee congratulated the graduates of L.E.A.D. and from Woodrow Wilson School. She will be calling a meeting next week regarding the TNR program.

# Administrator's Report - Administrator Jardine

Administrator Jardine echoed congratulations to Mr. Doolittle. He also reported on the preconstruction meeting. Administrator Jardine explained the cannabis ordinance for consideration tonight was to implement application and fee structures.

# Public Comments – Agenda Items Only

Mayor Wardell opened the meeting to the public on agenda items.

Ms. Kelly Strazdas, Overbrook Place, asked about the amendments to the Cannabis Ordinance. Mayor Wardell explained it was to fill in the framework of the prior ordinance regarding the review committee, the application process and fee structure. Further discussion followed on the amendments and zoning. Ms. Strazdas asked about the opposition zoning. Mayor Wardell explained that currently locations have the ability to apply for a variance. Further discussion continued on the bill and the fact that it removes control from local entities.

C/Renee asked about Resolution 22-81 regarding the DPW contract; Administrator Jardine explained it is authorizing a side bar agreement to increase the starting salary which is currently below minimum wage when broken down by hour.

# **E. Application Process**

# Local licensing authority.

A Borough Cannabis Advisory Committee (CAC) appointed by the Mayor will act as the body for local review for the Borough for all cannabis establishments. Under all circumstances in which State Law requires communication to the Borough by the Cannabis Regulatory Commission or any other State agency with regard to the licensing of cannabis establishments by the State, or in which State Law requires any review or approval by the Borough of any action taken by the State licensing authority, the exclusive authority for receiving such communications and granting such approvals shall be communicated through the Borough Clerk's Office upon recommendation by the sign-off by the Borough Cannabis Advisory Committee and authorized by the Borough's governing body.

- 1. Members of said CAC shall include residents and business owners located within the Township. The appointees shall include, at a minimum, one (1) member from the following categories:
  - a) Mayor or designee.
  - b) Borough Administrator or designee.
  - c) Neptune City Chief of Police ordesignee.
  - d) Borough Planning Board Chair or Designee.
  - e) Borough Planner and/or Zoning Official.
- 2. Duties of the CAC shall be to advise the Borough governing body as to the issuance of cannabis business permits within the Borough based on the issuance of request for proposals issued by the governing body and the establishment of the criteria presented herein.

#### Effectiveness.

Under no circumstances shall a local permit for a cannabis establishment issued through the Clerk be effective until or unless the State has issued the requisite licenses to operate such a facility. It is the intent of this Chapter that no cannabis establishment may lawfully operate in the Borough without the issuance of a State license and full regulatory oversight of the cannabis establishment by the Cannabis Regulatory Commission or other New Jersey State licensing authority as well as the issuance of a cannabis business permit by the Borough.

#### **REVOCATION OF CANNABIS MERCANTILE REGISTRATION**

Any cannabis mercantile registration shall be deemed null and void at the discretion of the Chief Law Enforcement Officer of the Borough or any authorized Borough representative for violation of any Borough Ordinance, unless but not limited to a Dormant License as determined by the CAC and or any violation of any New Jersey State regulation shall be a basis for non-renewal.

#### PENALTY

Any person, firm, corporation or other business entity violating any of the provisions of this chapter shall, upon conviction, be punished by a fine not to exceed five hundred (\$500.00) dollars or by imprisonment in the County jail for a period not to exceed ninety (90) days, or both. Each violation of any of the provisions of this Chapter shall be considered a separate offense, and each day the violation continues to persist shall also be considered a separate and distinct offense.

#### Fees.

The following fees shall apply to all cannabis businesses:

Standard Businesses - Class IV:

- 1. Application Fee \$10,000.00
- 2. Annual Renewal Fee \$10,000.00

The above fees shall be submitted to the Borough at the time the cannabis business submits its Initial application or the renewal application to the Borough. If the cannabis business's application is denied, the Borough shall refund eighty percent (80%) of the Initial Application or Renewal Fee if the applicant is not approved for a cannabis license by the State of New Jersey.

The Public Hearing will be on Monday, July 25, 2022.

**WHEREAS**, by reducing Consolidated Municipal Property Tax Relief Act (CMPTRA), which is also comprised of revenues that should be returned to municipalities, State Budget makers have been able to continue collecting Energy Taxes, while keeping additional revenue that should have been returned to provide property tax relief; and

WHEREAS, the cumulative impact of years of underfunding has left many municipalities with serious needs and burdensome property taxes; and

WHEREAS, local elected officials are in the best position to decide the best use of these resources, which were always intended to fund local programs and services; and

# **OPPOSING A-1294/S-2103 AND URGING THAT SUCH LEGISLATION NOT ADVANCE FURTHER**

WHEREAS, local officials, because of their peculiar knowledge of local conditions, are in the best position to determine land use and zoning regulations; and

**WHEREAS**, this peculiar knowledge is used to develop a Municipal Master Plan, which is adopted with the goal of promoting the health, safety, and welfare of the public, and only after careful and thoughtful consideration by local officials for its compatibility and consistency with other state, county and regional plans, such as the State Development and Redevelopment Plan, the Coastal Area Facility Review Act, the Highlands Water Protection and Planning Act, the Pinelands Protection Act, the County Solid Waste Management Plan and Water Quality Management Plan; and **WHEREAS**, the Municipal Master Plan guides the determination to designate land use and zoning districts, which help effectuate the careful development plans and goals outlined within the Master Plan; and

WHEREAS, the Municipal Land Use Law lays out a comprehensive system allowing for and detailing the process in which applicants for development may seek to deviate from these careful and deliberate land use and zoning regulations through the municipal planning board's review of a variance; and

**WHEREAS,** consideration of a land use variance is done by local officials, taking into account the variety of circumstances including the proposed deviation's impacts on the goals of the Master Plan; and

**WHEREAS,** the Local Redevelopment and Housing Law provides municipalities with substantial tools to support the redevelopment of blighted sites, including the creation of site-specific redevelopment plans and numerous financial incentives; and

**WHEREAS,** legislation, A-1294/S-2103, has been introduced that would preempt local control over land use and zoning regulations, allowing certain qualifying office park and retail center properties to be permitted, as of right, to redevelop as a mixed-use development, not requiring a use variance; and

WHEREAS, A-1294/S-2103 requires a planning board approve an application for development to convert and eligible

property to a mixed-used development unless the application causes "substantial detriment to the public good" and "substantially impair[s] the intent and purposes of the zone plan and zoning ordinance", a vague standard that may be difficult if not impossible to overcome; and

WHEREAS, A-1294/S-2103 may interfere with municipalities implementing alternative visions for the redevelopment of office park and retail center properties, including as industrial sites, parkland, or sites for needed infrastructure; and

WHEREAS, A-1294/S-2103 would interfere with existing and potential Redevelopment Plans that were specifically developed to address office park and retail center properties; and

WHEREAS, A-1294/S-2103 does not take into account conditions such as flooding and future climate risk that may impact the suitability of a site for mixed-use development; and

**WHEREAS,** this top-down approach, eliminating local land use planning regulations undermines the recognized benefits of municipal land use regulation, without providing the appropriate review for deviation as outlined within the Municipal Land Use Law.

**NOW, THEREFORE, BE IT RESOLVED,** that the governing body of the *Borough of Neptune City* in the County of Monmouth opposes this legislation, and urges our representatives to not advance further A-1294/S-2103; and

**BE IT FURTHER RESOLED,** that a copy of this Resolution be forwarded to Senator Vin Gopal, Assemblywoman Piperno, Assemblywoman Eulner, Senate President Scutari, Assembly Speaker Coughlin, Governor Murphy, and the League of Municipalities.

WHEREAS, the Veterans property tax deduction has not increased since 2003; and

WHEREAS, Assemblyman Ronald S. Dancer has introduced Assembly Concurrent Resolution No. 31 proposing a constitutional amendment to increase the Veterans property tax deduction; and

**WHEREAS**, the proposed constitutional amendment would increase the fixed annual property tax deduction for New Jersey Veterans from \$250.00 to \$1,000.00 with future deductions to be based on the annual Consumer Price Index increase, and rounded to the next highest multiple of \$1.00; and

**WHEREAS**, the Monmouth County Board of County Commissioners supports the efforts of Assemblyman Dancer and urges the New Jersey Legislature to increase the annual property tax deduction for New Jersey veterans.

**NOW, THEREFORE, BE IT RESOLVED** by the Monmouth County Board of County Commissioners, State of New Jersey, that we hereby support Assembly Concurrent Resolution No. 31, which would increase the property tax deduction for Veterans to \$1,000.00 and base future deductions on annual Consumer Price Index increases.
