RESOLUTION 21-161 CREATING A VETERANS ADVISORY COMMITTEE

WHEREAS, the Borough has determined; in order to honor fallen Neptune City veterans, there should be an established Veterans Advisory Committee to assist the Governing body in identifying and properly honoring those veterans of the Borough who have made the ultimate sacrifice for this country, and

WHEREAS, the Borough would further like to assist all veterans who are residents of the borough by providing information on county, state, and, federal veterans programs and services available for veterans, and

WHEREAS, the Governing body would like to be made aware of any questions or concerns the veterans of Neptune City may have and recommendations on how to best those needs. N.J.S.A 40;60-7d. The Borough council may create such advisory councils to the municipality as it may choose, and

WHEREAS, one of the purposes of such advisory committee would also be to honor those Borough Veterans killed in action, though recognition of those individuals with commemorative street sign installations; and

WHEREAS, membership in the advisory committee shall consist of a maximum if five members appointed annually by the mayor, at least three of whom shall always be a veterans of the armed forces and residents of Neptune City and one member shall be the Commander of their designee of Local VFW Post #____.
