AN ORDINANCE APPROPRIATING \$77,500.00 FROM GENERAL CAPITAL IMPROVEMENT FUND FOR COSTS AND EXPENSES TO COMPLETE THE FOLLOWING IMPROVEMENTS AND PURCHASE THE LISTED EQUIPMENT, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE BOROUGH OF NEPTUNE CITY, AS FOLLOWS:

Section 1. The sum of \$77,500.00 is hereby appropriated from General Capital Improvement Fund for Costs and expenses to complete the following improvements and purchases,

| Municipal Building Improvements | \$20,500.00 |

Section 3. The capital budget of the Borough of Neptune City is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith.

resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services is on file with the Clerk and is available there for public inspection.

Section 4. The expenses hereby authorized consist of municipal building improvements, municipal building IT equipment, public works equipment, police equipment and to purchase fire equipment. The period of usefulness for these listed items is a minimum of five (5) years.

Section 5. This ordinance shall take effect as provided by the law.
