AN ORDINANCE APPROPRIATING \$60,000.00 FROM SEWER CAPITAL IMPROVEMENT FUND FOR COSTS AND EXPENSES TO PURCHASE ONE (1) NEW 2019 FORD F-750 TRUCK FOR THE PUBLIC WORKS DEPARTMENT

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE BOROUGH OF NEPTUNE CITY, AS FOLLOWS:

Section 1. The sum of \$60,000.00 is hereby appropriated from Sewer Capital Improvement Fund for Costs and expenses to complete the following improvements and purchases,

One (1) New 2019 Ford F-750 Truck

Section 3. The capital budget of the Borough of Neptune City is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services is on file with the Clerk and is available there for public inspection.

Section 4. The expenses hereby authorized consist of one (1) new 2019 Ford F-750 truck. The period of usefulness for these listed items is a minimum of five (5) years.

Section 5. This ordinance shall take effect as provided by the law.
