Per P.L. 2022, c. 92: Owners of residential and non-residential spaces will be required to annually register the certificate of insurance in the municipality where the business or rental unit is located. Owners of a businesses, or one or more rental units, must maintain liability insurance for negligent acts and omissions in an amount of no less than \$500,000 for combined property damage and bodily injury to or death of one or more persons in any one accident or occurrence. Property owners who do not file annually a copy of their certificate of insurance may be subject to a fine of not less than \$500, but no more than \$5,000, against an owner failing to comply with the law
